PERFORM A STRAND TEST TO DETERMINE HOW LONG TO COLOR YOUR HAIR TO ACHIEVE YOUR DESIRED SHADE. DO THE ALLERGY TEST AT LEAST 48 HOURS BEFORE COLORING YOUR HAIR.

STEP 1

PREP BEFORE COLORING:

STEP 4

• Process color for 5 to 30 minutes depending on how bold you want your color. The shorter the processing time, the lighter the color will be

WARNING: DO NOT RUB PRODUCT INTO SCALP OR COLOR WILL STAIN, IF COLOR GETS ON YOUR SKIN. WIPE OFF WITH A DAMP CLOTH **IMMEDIATELY, OR USE COLOR OOPS COLOR**



STEP 2

USE GLOVES:

- Put on gloves, or your hands will match your hair.
- Protect forehead, neck, and ears with petroleum ielly to prevent staining of the skin

CLOTHES, AND ANY SURFACE IT COMES IN



STEP 5

RINSE HAIR

- · Rinse hair well, and with cold water to avoid staining and to help lock in color.
- Always use an old towel when drying hair.

STEP 3

SHAKE COLOR:

 Shake Splat Color bottle thoroughly prior to applying color to hair.

FINISHED:

SKIN ALLERGY TEST FOR HAIR DYE

IMPORTANT: THIS PRODUCT CAN CAUSE AN ALLERGIC REACTION. WHICH IN CERTAIN RARE CASES. CAN BE SEVERE. TO HELP MINIMIZE THE RISK OF AN ALLERGIC REACTION, YOU MUST FOLLOW THESE PRECAUTIONS:

SKIN ALLERGY TEST INSTRUCTIONS:

- CLEANSE AN AREA THE SIZE OF A QUARTER IN THE BEND OF YOUR ELBOW WITH SOAP AND WATER. PAT DRY.
- APPLY MIXTURE TO THE TEST AREA WITH A COTTON SWAB OR COTTON BALL. TIGHTLY RECAP THE BOTTLE.
- LET TEST HAIR COLOR DRY. DO NOT WASH, COVER OR DISTURB FOR 48 HOURS.
- EXAMINE TEST AREA PERIODICALLY OVER THE NEXT 48 HOURS. IF YOU EXPERIENCE ANY REACTIONS—SUCH AS REDNESS. BURNING. ITCHING. SWELLING. SKIN ABRASIONS. ERUPTIONS OR IRRITATION IN OR AROUND THE TEST AREA. DO NOT COLOR YOUR HAIR UNTIL YOU CONSULT A DOCTOR.

STRAND TEST INSTRUCTIONS

TO PREVIEW YOUR HAIR COLOR RESULTS, WE SUGGEST YOU PERFORM PRELIMINARY STRAND TESTS:

STRAND TEST:

- 1. PUT ON PROTECTIVE GLOVES.
- 2. CHOOSE 20 TO 30 STRANDS OF HAIR TO TEST. IT IS BEST TO CHOOSE AN AREA OF HAIR THAT WILL NOT BE CLEARLY VISIBLE WITHIN YOUR TYPICAL HAIRSTYLE.
- 3. USING PLASTIC CLIPS. SEPARATE THE REST OF YOUR HAIR AWAY FROM THE TEST STRANDS, SO THAT THE TEST STRANDS DO NOT TOUCH THE REST OF YOUR HAIR AFTER THE HAIR COLOR HAS BEEN APPLIED
- 4. APPLY HAIR COLOR ONTO TEST HAIR STRANDS UNTIL FULLY SATURATED.
- 5. AFTER 5 MINUTES WIPE A SMALL AREA OF COLOR AWAY AND INSPECT THE RESULTING HAIR COLOR. IF THIS RESULT IS TOO LIGHT. THEN ADD COLOR BACK TO THE AREA YOU WIPED CLEAN. REPEAT EVERY 5 MINUTES, UP UNTIL 30 MINUTES OR UNTIL DESIRED RESULTS ARE ACHIEVED.
- 6. NOTE TIMING AND USE FOR FULL APPLICATION.

COLORING HAIR

- AVOID CONTACT OF PRODUCT WITH SKIN, EYES, AND CLOTHES. DO NOT USE PRODUCTS TO COLOR EYELASHES OR EYEBROWS.
 - O IF PRODUCT GETS ON THE SKIN. WASH IMMEDIATELY WITH WATER AND PLENTY OF SOAP, IF SKIN IRRITATION OCCURS, GET MEDICAL ATTENTION.
 - O IF PRODUCT GETS INTO THE EYES. RINSE IMMEDIATELY WITH WATER. IF YOU ARE WEARING CONTACT LENSES. REMOVE THEM BEFORE RINSING YOUR EYES, CALL A DOCTOR IF IRRITATION PERSISTS
- AVOID BREATHING DUST, FUMES, GAS, MISTS, VAPORS, SPRAYS, ETC, FROM THESE PRODUCTS. THESE PRODUCTS MAY CAUSE BREATHING DIFFICULTIES AND/OR ALLERGY AND/OR ASTHMA SYMPTOMS. PREPARE AND USE PRODUCTS IN EITHER A WELL-VENTILATED AREA OR OUTDOORS.
